Important Questions	Answers	Why This Matters:
What is the overall deductible ?	\$2,500 person/ \$5,000 family	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this plan begins to pay. If you have other family members on the policy, the overall family <u>deductible</u> must be met before the plan begins to pay.
Are there services covered before you meet your deductible ?	Yes, the deductible is waived for preventive care, screenings, and immunizations	For example, this plan covers certain <u>preventive services</u> without <u>cost-sharing</u> and before you meet your <u>deductible</u> . See a list of covered <u>preventive services</u> at https://www.healthcare.gov/coverage/preventive-care-benefits/
Are there other deductibles for specific services?	No	You don't have to meet <u>deductibles</u> for specific services.
What is the out-of-pocket limit for this plan ?	\$7,500 person/ \$15,000 family for medical; \$1,500 person/ \$3,000 family for prescription drugs.	The <u>out-of-pocket limit</u> is the most you could pay in a year for covered services. If you have other family members in this plan , the overall family <u>out-of-pocket limit</u> must be met.
What is not included in the out-of-pocket limit ?	Premiums (deductions), <u>balanced-billed charges</u> , health care this plan doesn't cover, and penalties for failure to obtain pre-certification for services. Prescription drugs have a separate <u>out-of-pocket limit</u> . Lifestyle medications will not apply towards the prescription drug annual <u>out-of-pocket maximum</u> .	Even though you pay these expenses, they don't count toward the <u>out-of-pocket limit</u> .
Will you pay less if you use a network provider ?	Not Applicable.	This plan does not use a provider network. You can receive covered services from any provider.
