

PPO Plan

What is the overall <u>deductible</u> ?	<u>Network</u> : \$500 Individual / \$1,000 Family Out-of- <u>Network</u> : \$1,000 Individual / \$2,000 Family per calendar year.	Generally, you must pay all of the costs from providers up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your <u>deductible?</u>	Yes. <u>Preventive Care</u> , primary care, specialist visit, urgent care services with <u>copay</u> are covered before you meet your <u>deductible</u> .
